In Japan

In the early morning of the 11th of February 2003 while living in Japan, I found myself dreaming I was in Japan at the shore of the sea on a white sandy beach. Many people were around and participating in normal 'beach' activities. It looked like a beach park with modern structures in the area. Among others who were there, I saw the Japanese royal family also enjoying the shoreline park on a warm afternoon.

Son Kidnapped

As I watched the Japanese royal family on the beach, I witnessed their son being kidnapped by a 'witch'. She seemed to have a Wicca /Buddhist/ Shinto spirituality with others assisting her doing the kidnapping.

She was strongly confronted by the Emperor but she said to him she would not return the son unless the royal house would agree to allow what she described as the 'Land of the Eastern Cross' to go to a court of spirits so the witch could argue her claim for the land and its people.

It was implied she already had power over the rest of Japan except for this one geographical area. She was using the son of the Emperor to blackmail him into allowing this to occur. In Japanese Shintoism, the Emperor is considered a Shinto god and and is the head of the Shinto religion by being the Emperor.



Right after this scene a map was revealed to me in the dream showing the land shape of the outline of southern Japan. On this map were scalloped lines (about every 50 miles apart) emanating from the north moving south than to the southwest corner of the land mass in southern Japan. This is not far from where I lived in Sasebo when I received this dream.

The last scalloped section was the small province (number 59 above) that was identified as being under dispute by the witch and identified as the 'Land of the Eastern Cross' in the dream located to the South West part of the province of Kyushu Island.

Land of the Eastern Cross

It seemed that this piece of land had not yet come under the spiritual rule of the Shinto 'witch'. Her claim was to be argued in the court of spirits (both demons and angels) with the right of the land given to those who could expertly argue their rights and win according to spiritual law.

The witch said that if the Royal family would not comply to the court proceedings, their son would die young. If they did comply to the proceedings, he would live to be more than 70... "even to the age of 99" that was described as a "romantic age" by the witch in the dream.



No other children were identified in the dream as heirs to the Royal family line.

I got up from the rock where I was sitting while watching all this and challenged the witch. Looking into her eyes I said, "I would argue the claim for the province for YHWH and win."

She was visibly unsettled. To have this right to argue, I had to have the 'right' to the land granted to me by the Royal Family and prove that I had historic connection to the land by both my spiritual lineage and family lineage.

In the dream I turned and addressed the Japanese Emperor and clarified that I am a distant son of King David. I explained King David was also in the bloodline of the 'Hata no Kawakatsu" clan from whom the Emperor had descended. I also clarified that I was first ordained a Nestorian (Keikyo) priest thus giving me this right according to the original



founding Church in the "Land of the Eastern Cross" to have the right to speak for them. The dream then ended.

In prayer and reflection after the dream, I had the following understanding:

1) The Land of the Eastern Cross was the original land given to the first Hebrew-Christian missionaries who came into Japan in 198 AD from Korea and China. 2) The 'The Land of the Eastern Cross' was also the land (and islands) to which the Christians escaped

during the great Buddhist persecution between the 16th and 19th centuries in the region of the South-West coast of

Japan.

3) There was a sense that prayer needs to occur at specific hallowed sites in this region that may have been

associated with this escape and as the home of the early 3rd century Hebrew Christians.

4) From this protected site, the power of the Holy Spirit would then be able to spread to the North in claiming Japan back for the Kingdom of God. This was indicated by the scalloped lines on the map I saw.

Now 10 years later at the writing of this book, this message is still very relevant to the revival that is to come to Japan. This dream has identified the strong man (Shinto witch woman) that keeps the Japanese people from hearing the Gospel. Having lived in Japan for 2 years, I was able to make contact with a Hada/Hata who is also a Roman priest. He became an associate member of the Culdee. He taught me many things about the culture of Japan and about the Royal Family who are his cousins.
