

# Cuozzo Under Curse of Korah

## Witness of Court

On the night of the 3<sup>rd</sup> of December 2015, I found myself in some kind of heavenly place among a vast number of people who had gathered before a throne with Y'Shua sitting upon this throne. I do not think it was in heaven but some other place of judgment – perhaps on the earth upon some mountain top somewhere. Angels and humans were seen attending this court session in vast numbers. They were all standing around and facing the throne upon which Y'Shua sat. I could see Greek or Roman like temple structures in the background at some distance although the assembly or “court of heaven” were gathered in a vast area with a white marble like floors. I could see no walls or roof so it seemed like it was outside. Amazingly there was no sun – the light was everywhere and not from a single source. Perhaps this was some interdimensional place that was lit by the light of YHWH.

I then heard an angel yell out in the assembly,

“What judgment has not yet been fulfilled that can be used against this rebellion?”

A voice then rang out from the assembly,

“The judgment of Korah!”

I then heard Y'Shua say,

“Let it be so.”

## Background

Still in a state of awareness of these surroundings, I realized this was a judgment for the recent action of a Mr. Michael Cuozzo who had left my charge three days ago. I was his avowed bishop and in his rebellion, he is now leading away 7 other priests with him in this rebellion. This Mr. Cuozzo had been entrusted by me with a leadership role in a project I had been a part of for 30 years in bringing Roman Priests who had married back into sacramental service. For him who I trusted, I created a religious order called the “Orde' Franciscanus Oecumenicis” (Order of Francis Ecumenical) and appointed him in as a priest of Roman orders to become as a priest within the Order of the Culdee. The issue between us is he had accepted a Jesuit onto his advising board which I had banned due to their Luciferian activities and upon hearing this, I told him this cannot happen in knowing the mission of the Jesuits within the New World Order Antichrist regime.

This Mr. Cuozzo then rebelled and is now leading seven married Roman Priests away from our jurisdiction directly into the hands of the Antichrist Jesuits. ## **Judgment of Korah**

The judgment of Korah that some call the Curse of Korah occurred during the time of Moses.

The story of the rebellion of Korah is recorded in [Numbers 16](#). The rebellion of Korah demonstrates the grim consequences of usurping the authority of God and of those whom He has chosen to be leaders of His people.

Korah was the oldest son of Izhar, who was the son of Kothath of the tribe of Levi. Korah, then, was of the same tribe as Moses and Aaron. He led a rebellion against Moses and Aaron, accusing them of exalting themselves above the congregation of the Lord ([Numbers 16:1-3](#)). Korah was not alone in his charge. He gathered 250 other men to challenge Moses' authority as well: "You have gone too far! The whole community is holy, every one of them, and the Lord is with them. Why then do you set yourselves above the Lord's assembly?" ([Numbers 16:3](#)).

Obviously, Korah thought that he could do a better job leading the people than Moses was doing. But by leading this revolt against God's divinely appointed leaders, Korah was actually revolting against God ([Numbers 16:11](#)). Moses proposed a test to prove the source of his authority. Korah and his followers did not pass the test, and God opened up the earth and swallowed the rebels, their families, and all their possessions. Furthermore, "fire came out from the LORD" and consumed the other 250 men who were party to Korah's rebellion. The rest of the Israelites were terrified and fled ([Numbers 16:31-35](#)).
