#### **Leviticus 6:1-5**

1. And the LORD spake unto Moses, saying, 2. If a soul sin, and commit a trespass against the LORD, and lie unto his neighbor in that which was delivered him to keep, or in fellowship, or in a thing taken away by violence, or hath deceived his neighbor; 3. Or have found that which was lost, and lieth concerning it, and sweareth falsely; in any of all these that a man doeth, sinning therein:

4. Then it shall be, because he hath sinned, and is guilty, that he shall restore that which he took violently away, or the thing which he hath deceitfully gotten, or that which was delivered him to keep, or the lost thing which he found, 5. Or all that about which he hath sworn falsely; he shall even restore it in the principal, and shall add the fifth part more thereto, and give it unto him to whom it appertaineth, in the day of his trespass offering.

#### **Exodus 23:4**

4. If thou meet thine enemy's ox or his ass going astray, thou shalt surely bring it back to him again.

This is the spirit of the Law as applied to this situation. A man's (or woman's) property is to be returned to them even if found on another man's property or the possessor of these properties violate the Law of YHWH.
